USER MANUAL FOR MSME REGISTRATION PROCESS

1. Introduction

The software has been designed to facilitate registration of MSME in our SAIL-CMO site. The manual will guide you through the steps required to complete your registration by verifying your identity with an OTP (One-Time Password) and uploading three necessary documents in PDF format.

2. Requirements

Before you begin, ensure that you have the following requirements:

- A valid email address for OTP verification
- Access to a mobile phone for OTP verification
- A device with internet access
- The documents you wish to upload should be in PDF format, each under the size limit of 512 KB

3. Registration Process

Step 1: Access the Registration Page available in SAIL website (<u>www.sail.co.in</u>). On access the screen will be displayed as below

Step 3: OTP Verification

- 1. An OTP (One Time Password) will be received on the mobile number and Email address entered in the registration screen. If OTP is not received in In box of the Email, the spam folder may be checked for OTP.
- 2. The OTP received should be entered it in the field "Enter OTP" provided on the MSME registration page as shown in the screen.

3. Click **"Validate OTP"** to confirm the OTP. On successful validation of OTP, you will be directed to the document upload page.

Step 4: Upload Documents

- 1. After OTP verification, the screen will prompt to upload three documents in PDF format as shown in the screen below.
- 2. Click the **''Choose File''** button next to each document category to select the PDF file from your computer. Ensure each document does not exceed 512 KB.

- 2. You will receive a confirmation email on successful registration.
- 3. At this point, your registration process is complete.
- 4. You can edit all details except GST no any time after registration till you are given final credentials to place enquiries with SAIL.

4. Support

I did not receive the OTP. What should I do?

- OTP is available both in mobile and email . Check your inbox and spam/junk folder for the OTP email.
- Ensure that you entered the correct email address.

I cannot upload my documents.

- Ensure the documents are in PDF format.
- Verify that each document is under 512 KB.
- If the issue persists, try refreshing the page or uploading from a different device.
